Hold a Shabbaton weekend for High School students to build Jewish pride and focus on workshops and seminars to combat antisemitism with opportunities to use tools learned.

PROJECT OVERVIEW

As part of their curriculum CTA High School students will go on a Shabbaton from Friday to Sunday that will be held out of town. The purpose of the Shabbaton will be community building with emphasis on combating antisemitism and strengthening Jewish knowledge, pride, and connection to the state of Israel. Israel education is more than just being advocates. By learning about Israel's founding, history, values, and community, students will gain perspective that they can use to combat antisemitism and become strong advocates in their communities both local and when they graduate from high school. Workshops and seminars over the weekend would include experts in the field as well as CTA teachers. Beginning in Fall 2025, CTA is looking forward to welcoming an Israeli Shlichim family to work at CTA and live in Columbus. Their role will be to expand our students' understanding of what it is like to live in Israel in a post October 7 world. Their background in Israel education and leading workshops like we are planning will be an important part of this project and the Shabbaton will be a great start to their relationships with the students. Leading up to the Shabbaton, students would engage in preparations and potential speakers. The Shabbaton would be a highlight of the Israel advocacy education at CTA. A Shabbaton is a valuable medium for this type of learning as it creates bonds for the students that go beyond the classroom and reinforces priorities in Jewish life and learning. Follow up would include connecting to a local Hillel or Chabad and their students to see how campus Israel advocacy works and for the high school students to share what they have learned.

What is the size of and who is the target population?

Population is CTA High School which is 50 plus students and also includes teachers, chaperones, and speakers.

How does this project serve a Jewish population? (up to 30 words)

As the only Jewish high school in Columbus, the mission of CTA is to strengthen students' connection to Israel and the Jewish people as a source of pride, strength, and advocacy.
